**PMP Committee Report:** B. Mansfield reported on the PMP Committee Report. The K-Tracs Prescription Monitoring Advisory Committee met on December 4, 2020. The prior meeting was held on October 16, 2020.

C. Moreland reported on K.S.A. 65-1682. This was a proposed regulation that was introduced to the Legislation in 2020 from the Board of Pharmacy. The proposed regulation did not get worked in committee. The Board of Pharmacy will be reintroducing the proposed regulation K.S.A. 65-1682 with a few changes to Legislation in 20201. The Board of Pharmacy is requesting feedback from the Board of Nursing on this proposed regulation before they reintroduce to Legislation in 2021.

**CNM-I Regulations:** C. Moreland reported there is no update on the CNM-I Regulations.

**HB2412:** C. Bragdon reported that Amy Siple, KAPN President will be introducing HB2412 to Legislation in 2021.
