Due to social distancing requirements, we must limit the number in our lobby to no more than 2 at a time. It is highly recommended that you conduct your business with the Board of Nursing via online services, mail, phone call, email or by making an appointment (785-296-2967). There is a secure drop box located outside of the agency that is available for anyone to drop off documents for the Board of Nursing. There is a button to push by the agency door to gain access to the agency. KSBN NO longer performs fingerprinting services in the agency. The majority of staff continue to telework to decrease possible exposure. The best way to contact them is via their email. - ⇒ **Agency processing times:** There are licensing requirements that must be met before a license can be issued. This includes information that must be reviewed and processed once received in our agency. **It slows processing times when staff must respond to numerous emails and phone calls as to whether a piece of information has been received and processed.** Please continue to check your application checklist as we will update it as information is processed. Another important reminder, licenses are issued on an individual basis and times may differ for each applicant. If an applicant has a legal background, legal information must be reviewed prior to the applicant being approved for licensure.
- ⇒ **License expiration dates:** Executive Order No. 21-22 was signed by Governor Kelly on April 27, 2021. It states any renewal fees, deadlines, or other requirements extended pursuant to Executive Order 21-09 (and its predecessor orders) shall remain extended until at least 15 days after the licensing authority provides notice to licensees through publication on the agency's website or through other electronic means regularly used by the agency to communicate with the agency's licensees. **This means that licenses that had/have an expiration date of March 31, 2020 through July 31, 2021 have an expiration date of August 28, 2021. These licenses will be lapsed if not renewed by August 29, 2021. This notice will be placed on our website. There will be NO extension past this date! If any of these licenses lapse on August 29, 2021, the license will have to be reinstated and the licensee will not be able to work as a nurse until the license has been reinstated.** The required 30 hours of continuing nursing education must be completed at the time of renewal. Licensees can continue to renew at the normal expiration date.
- ⇒ **Important reminders about prior provisions that have expired:**
- Licensed APRNs and CRNAs may provide healthcare services appropriate to their advanced practice education, training and experience within a designated healthcare facility at which they are employed or contracted to work as necessary to support the facility's response to the COVID-19 pandemic without direction and supervision from a responsible physician (**expired March 31, 2021 no longer in effect**)
 - A RN or LPN may order the collection of throat or nasopharyngeal swab specimens from individuals suspected of being infected by COVID-19 for purposes of testing (**expired March 31, 2021 no longer in effect**)
 - A LPN may provide healthcare services appropriate to such LPN's education, training and experience within a designated healthcare facility at which the LPN is employed or contracted to work as necessary to support the facility's response to the COVID-19 pandemic without direction from a RN (**expired March 31, 2021 no longer in effect**)
 - A RN or LPN who holds a license that is exempt or inactive or whose license has lapsed within the past five years may provide healthcare services appropriate to the nurse's education, training and experience without an active license to practice. Such RN or LPN shall not be liable in any criminal prosecution, civil action or administrative proceeding arising out of such nurse's exempt, inactive or lapsed license (**expired March 31, 2021 no longer in effect**)
 - A nurse licensed and in good standing in another state may practice nursing in the state of Kansas. For purposes of this subsection, a license that has been suspended or revoked or a license that is subject to pending license-related disciplinary action shall not be considered to be in good standing. (**expired March 31, 2021 no longer in effect**)
 - Nurses meeting the requirements may have their license reinstated within five years of lapse without the requirements of continuing education and payment of a fee. (**expired March 31, 2021 no longer in effect**)
