Call to order: The APRN Committee meeting was called to order by Carol Bragdon, PhD, APRN, Chair, at 2:00 p.m. by Zoom virtual meeting.

C. Bragdon stated because the APRN Committee is conducting this public meeting by Zoom, she stated for the record the following information:

On June 3, 2021, the Board sent notice of the meeting for the APRN Committee to all individuals who have requested notice of the Committee’s meetings. Review of Onsite Packets: There was nothing for the onsite packet.

Add/Rev. Agenda: There were no additions/revisions to the agenda. It was moved to approve the agenda as written. Motion #1 Mansfield/Gosnell Adopted.

Announcements: Carol Bragdon announced this will be her last APRN Committee meeting as her term expires on 6/30/2021. She has enjoyed her time on the Committee.

Minutes: The minutes from the March 23, 2021 APRN Committee meeting were reviewed. It was moved to approve the March 23, 2021 APRN Committee minutes as written. Motion #2 Zeller/Mansfield Adopted.

Unfinished Business:

PMP Committee Report: B. Mansfield reported on the PMP Committee Report. The K-Tracs Advisory Committee continues to meet on a regular basis. The next meeting will be on Friday, June 18, 2021. During the last meeting legislation was discussed on what was proposed. This proposed legislation did not advanced. The legislation that was initially proposed was to have a NP to represent the Board of Nursing. What was submitted was written as either a PA or a NP. The State Board of Nursing really needs to have a NP representing the K-Tracs Committee. C. Moreland reported that KSBN will not need to contribute anything for K-Tracs for FY21. KSBN will need to start contributing around \$70,000.00 for FY22 and FY23.

CNM-I Regulations: C. Moreland reported on the CNM-I Regulations and gave an update that she received from Kansas State Board of Healing Arts. There is a meeting of the Advisory Committee scheduled for mid-summer. The minutes from their last meeting. KSBHA received four applications and have issued four licenses.

Nurse Midwife Update: C. Moreland reported on the Nurse Midwife Independent Advisory Committee Membership update. The Board of Healing Arts does not have a term limit. It's up to the Board who does the appointing. It was moved to appoint term limits to the Nurse Midwife Independent Advisory Committee membership of Cathy Gordon, Terena Sisk, Cara Busenhardt and Jamie Harrington. Rotating two members terms every two years. There will be no limit to how many terms a member can serve. Motion #3 Zeller/Watson Adopted.

5-year Legislative Review:
