Initial LTP Applications:


Last Made First – It was moved to approve the Initial CNE Provider application for Last Made First. Motion #14 Owen/Burnett Adopted


MedAlign Innovative Solutions LLC – The policy included in the application says they are awarding fraction of hours for contact hours. For 30 minutes of learning they will give .5 contact hours, also education and experience of the coordinator was not explicitly provided in the CV, but it was in the biography for the CE offering that the coordinator would be working on. Discussion was had on the regulation 60-9-107 (e) that states how contact hours can be awarded. C. Moreland will research regulation 60-9-107 (e) and bring back an interpretation to the September meeting. The committee will have the option to revise the regulation at that time. This regulation has been approved by the Department of Administration and Attorney General but not through the entire process, it is waiting for 60-9-106 to be reviewed. C. Moreland will Work with C. Macheers to research this regulation. The committee would like for C. Stephenson to communicate to the

providers that the committee is reviewing this regulation and they need to update the contact hours awarded to meet the regulation as it is written now. It was moved to approve the Initial CNE Provider application for MedAlign Innovative Solutions LLC pending updated policies. Motion #15 Burnett/Aufdemberge Adopted
