Call to Order: The Practice Committee meeting was called to order by Rebecca Sander, MSN, RN, Practice Chair, at 3:11 p.m. by Zoom Virtual meeting.

Unfinished Business:

5-Year Legislative Review: R. Sander discussed the language in the K.A.R. 60-7-105 – LMHT Standards of Practice regulations and if we need to remove the language “psychiatric-mental retardation” to “function primarily in a facility that provides services to the mentally ill, emotionally disturbed, or people with intellectual disability”.

The consensus of the Committee is to bring back to the September 2022 Committee meeting the revisions discussed today for the K.A.R. 60-7-105 regulations for review and approval.

RN LPN Scope of Practice: The RN LPN Scope of Practice Components of Nursing Comparison Chart will be tabled until September 2022.

New Business:


Practice Questions: L. Davies discussed the amount and types of practice questions that are received. During the month of May 2022 there were 67 calls and 16 emails. Most of the calls are from APRN’s, RN’s, LPN’s and facilities. The volume is specifically from RN’s and then facilities. Seeing an increase in LLC applications and questions from LPN’s, RN’s and APRN’s wanting to start their own LLC.

Nurse Honor Guard: L. Davies reported that a question was received concerning a nurse who had passed away and the question was asked if Kansas had a Nurse Honor Guard in Kansas that would honor a nurse who had passed away. Will be forwarding the question on to KSNA.


