Call to order: The APRN Committee meeting was called to order Melissa Oropeza, DNP, APRN-BC, CGRN, Vice-Chair, at 2:04 p.m. by Zoom virtual meeting.

PMP Committee Report: S. Gregg reported on the PMP Committee Report. Shannon reported that KTRACS Committee met on May 5, 2022 and discussed the Senate Bill 200.

CNM-I Regulations: Courtney Cyzman, General Counsel with the Kansas State Board of Healing Arts reported on the CNM-I Regulations.

- a. K.A.R. 100-28b-8 – Title; prohibited acts; act not to include certain individuals
- b. K.A.R. 100-28b-9 – Scope of practice; limitations
- c. K.A.R. 100-28b-11 – Licensees who direct, supervise or delegate acts that constitute the independent practice of midwifery; requirements and limitations
- d. K.A.R. 100-28b-19 – Unprofessional conduct

The consensus of the APRN Committee is to refer to KSBHA for further review the CNM-I Regulations Council K.A.R. 100-28b-8 and K.A.R. 100-28b-9 and to conduct a roll call vote of the CNM-I Regulations K.A.R. 100-28b-11 and K.A.R. 100-28b-19 at the June 29, 2022, Board meeting.

There are two implementation dates for these regulations with the first implementation date being 7/1/2022 that involves the temporary regulations. These would be good for 120 days. A public hearing will be held on 9/6/2022. All comments received during the 60-day comment period and the public hearing with the proposed permanent regulations will go before the Board for review and possible adoption at the September 2022 Board meeting. Once they are adopted, they will then be published in the Kansas Register and will have an implementation date 15 days after publication in the Kansas Register.
