CGFNS Course by Course Evaluation Report-

The **Commission on Graduates of Foreign Nursing Schools®** was established in 1977 to provide license verification, testing, and credentials evaluation of graduates of nursing schools to determine eligibility for nursing practice in the United States.

CGFNS offers several different options:

Credentials Evaluation Service Academic Report- this provides a course-by-course analysis of all *nursing* education received outside of the US. It is advisory in nature and is used for academic admission purposes.

VisaScreen Certificate- Visa Credentials Assessment Service is a screening service for healthcare professionals seeking an occupational Visa to work in the US.

CGFNS Certification Program- Consists of three things: A credentials evaluation assessment of secondary school education (high school), verification of registered nursing licensure and completion of a registered nursing program, the CGFNS Qualifying Exam, and Evidence of passing one of the approved English Language Proficiency examinations.

Credentials Evaluation Service Professional Report- this provides a detailed analysis of nursing credentials earned outside the US. For this report, CGFNS validates and authenticates all licenses, registrations, and diplomas obtained by the applicant. It also includes a statement of comparability of an applicant's nursing education assessed against US nursing standards.

IF educated outside of the US and trying to obtain license in Kansas: Kansas will require a CES professional report to be submitted to us directly from CGFNS.

Who orders this report:

The nurse will contact CGFNS directly to start this process. (Usually happens after submitting application to BON.)

Why is this report beneficial:

It assesses the competencies of foreign educated nurses and makes sure that their education meets our standards for licensure in our state.

For Kansas there are two instances in which this may be needed:

1. Initial application (Applicants are not made eligible to test until after this is received and approved.)
2. Endorsement application

CGFNS course by course report takes the places of the transcript requirement for the application.
