HB 2280: Kendra Wyatt discussed HB 2280. It was moved to have Board of Nursing representation on the Kansas Chapter ACNM sponsored legislative task force. Motion #3 Busenhart/Eagleson Adopted.

Position Statement for APRNs in Kansas:

Mary Blubaugh discussed position statement for APRNs in Kansas. Kansas statute KSA 65-1130 (d)(2) states responsible physicians must be licensed in Kansas, therefore, will not need a position statement.

Exempt License Status: Mary discussed KSA 60-11-121. The statutes state exempt license shall be granted only to an Advanced Practice Registered Nurse in Kansas who meets these requirements: 1) is not regularly engaged as APRN in Kansas, but volunteers APRN services or is a charitable health care provider, 2) has a license in Kansas for five years before applying for an exempt license. The consensus of the committee is for Mary to take this forward to the Board.

Legislative Review: It was moved to approve KSA 65-1151, KSA 65-1152, KSA 65-1165, KAR 60-13-111 and KAR 60-13-113 for a five year period without changes. Motion #4 Moffitt/Nyght Adopted.
