HCC:

Hutchinson Community College ADN Program represented by Debra Hackler, MSN, RN requests to revise the curriculum for the LPN/Paramedic Bridge Program with the courses NR123 Health Maintenance Promotion and Restoration and NR123L Health Maintenance Promotion and Restoration Practicum and decrease overall credits from 70 to 69.

Rationale for the change: The LPN/Paramedic Bridge program needs to align with the new curriculum brought forward to the March 2016 KSBN Education Curriculum Committee meeting regarding HCC "Traditional" program.

It was moved to accept the Major Curriculum Change Request from Hutchinson Community College ADN Program to revise the curriculum for the LPN/Paramedic Bridge Program with the courses NR123 Health Maintenance Promotion and Restoration and NR123L Health Maintenance Promotion and Restoration Practicum and decrease overall credits from 70 to 69. WU:

Washburn University Graduate Post Graduate Certificate Program represented by Monica Scheibmeir, PhD, APRN, FAANP requests to add a two credit course to the Post Graduate Psychiatric Mental Health Certificate Program. This course was designed specifically for the non-APRN Master's prepared nurses who are admitted to the PMHNP Certificate Program to become Psychiatric Mental Health Nurse Practitioners.

It was moved to accept the Major Curriculum Change Request from Washburn University Graduate Post Graduate Certificate Program to add a two credit course to the Post Graduate Psychiatric Mental Health Certificate Program. This course was designed specifically for the non-APRN Master's prepared nurses who are admitted to the PMHNP Certificate Program to become Psychiatric Mental Health Nurse Practitioners. Motion #11 Bragdon/White Adopted. Catanzaro abstained.

Canadian NCLEX:

Carol Moreland discussed Canadian NCLEX. KSBN has started getting requests from nurses who have taken NCLEX in Canada wanting to be licensed in Kansas. Canada is a foreign country of the United States. Our

regulations require foreign nurses to complete the CGFNS process. Part of that process would tell us if they were taught in English with English text books. If not they would then be required to complete the TOEFL report and would need to show documentation of English proficiency.

Canada began offering in 2015 the NCLEX-RN exam. New Brunswick is one province where the NCELX-RN can be taken in French. Our regulations require applicants to pass the licensure exam offered by National Council. It does not state that the NCLEX exam must be taken in English.

The 2016 Nursing and MHT Program Site Visit Schedule were reviewed. Carol Moreland will be emailing committee members for assistance with the site visits.

Paramedic/Mobile Integrated Health Care Course Update:

Carol gave an update on the joint meeting between Board of Healing Arts and Board of Nursing. There was some concern that this might be encroaching on the scope of nursing. Community paramedics work under a medical director. It was determined that if anything comes out of this practice it will actually be between the Board of Healing Arts and Board of EMS. The Board of Nursing would not be part of the jurisdiction.

Education Regulations Review:

Patsy gave an update. The Education Committee has been working hard on the Education Regulations. Will meet again in September and hopefully the first step of the Regulations will be able to be brought to the Board at the December 2016 Board meeting.

Miscellaneous:

Petition Data:

Carol discussed the petition data summary. Guidelines changed in June 2011. The NCLEX pass rates prior to June 2011 for petitioners were 12%. Since implementation pass rates have increased. Mary Blubaugh and Carol Moreland plan to write an article for the National Council concerning our guidelines.
