Retention of Investigative Files:

C. Moreland met with the Historical Society reference keeping documents. Documents can be kept electronically and not on paper. Marilyn Nicol has started scanning.

According to the KNPA our files must be kept forever. The committee asked if the wording can be changed from forever to a set year? Does the KNPA or statue need to be changed? C. Moreland will research before the December Board Meeting.

Electronic format for Investigative Committee notebook:

C. Moreland asked if the committee would be willing to go paperless and receive the notebook electronically via their tablets.

At this time the committee members are not interested.

Process concerns:

- a. Negligence vs. Gross Negligence The Committee discussed the definitions between ordinary negligence and gross negligence
  - Ordinary Had a duty but didn't do it
  - Gross Careless on purpose, should've known harm could happen
- b. Processing apps with pending investigation The Committee stated according to the AAGs we are to look at a Conversion application the same as a Renewal application. To grant even if have an on-going investigation. We can't deny if meets all 11 criteria.
- c. If don't meet all 11 criteria
  - The Committee stated that the nurse applicant will not get their money back for the application.

- o The application will be marked ineligible for a multi-state license and sent back to the applicant.
- o If endorse in and don't qualify the nurse needs to submit and pay for a single state application
- C. Moreland and L. Davies will review policy and procedure for the December meeting

## **Setting Priorities and Assignment of Investigative Cases:**

C. Moreland brought a question to the board reference how we categorize complaints. As most get categorized as a 2 we need to review how we categorize the 2. Also, the 4s are lapsed and do not go to committee. The Committee brought up the concerns of inactivating cases of lapsed license who might have an out of state multi-state license. C. Moreland and L. Davies will review procedure for December meeting.
